- Contributions from Catrina and Felipe in onboarding new members;
- two new office positions established in the Bureau: Members extensions and integration officer, who will be in charge of new and existing members and the Corporate Counsels Officer, who will organise a Corporate Counsels Committee as well as events and propose topics that are relevant to this group;
- In 2024 and 2025, the Bureau met online on a monthly basis, and two in-person meetings were organised in Vienna (January 2025) and Budapest (June 2025);
- The Bureau continued to its work especially in regard to these matters: Website/IT, Communications, New members, Scientific Committee, Finance, Sponsorship;
- In order to learn more about its own members, the LIDC sent out 2 short questionnaires to the national groups: in February 2025 the members were asked to share information on their activities and structure and in July 2025 the national groups were asked to circulate a short questionnaire on potential contributors to future LIDC webinars, panels, or working groups (“talent directory”).
- The NexGen Group has continued to be very active, organising social activities at the London congress. The Hungarian NexGen initiative did a fantastic job organising a NexGen weekend in June 2025 in Budapest with an impressive program. In 2025, the first NexGen released its first podcast „Exploring Competition in Cloud and AI“ chaired by Ben Evans and was released in seven episodes (Youtube and Spotify). The NexGen Group is led by Nina Methens and supported by Felipe Oquendo regarding scientific and communication aspects. Dominik Bajger has been highly engaged in making the LIDC a lot more visible in Social Media, especially on LinkedIn and Instagram.

5. Treasurer’s Report and confirmation of approval of Financials 2025

Cecilia Torelem, Deputy Treasurer, presented the financial statements. The LIDC achieved a profit. The Deputy Treasurer mentioned the Congress as a key component of positive financial results for the LIDC.

- **Question B:** *“To what extent does intellectual property law recognize the evolving concept of “art,” also including in the context of AI-assisted creation, and how does this shape the limits between the different types of Intellectual Property Rights and their role in enabling innovation, investment and the monetization of creative outputs?”*
